

# Red Carpet Party Hire

The Hirer unconditionally accepts the following terms when hiring Equipment from Red Carpet Party Hire

## 1. Terms & Charges

Quotes are valid for a period of 30 days. Prices quoted are for one days hire unless otherwise specified. Prices are subject to change without notice. All orders are subject to a 50% deposit upon confirmation of hiring. Until this deposit is paid the booking is unconfirmed and we are not able to guarantee supply of quoted equipment. Final payment is required prior to delivery/pick up, unless previously arranged. Items cancelled up to 5 days prior to hire date will forfeit the deposit paid. Items cancelled upon or after delivery will be charged at the full rate. Installation and delivery is included in hiring rates however if extra labour is required under any circumstances then additional charges will be levied. Where possible the site will be inspected prior to hiring of equipment so as the quote provided will be as accurate as possible. All hire goods attract 10% GST. This is already included in the price quoted on the price list. A surcharge of 2% will apply for all credit card payments. A security bond may be required to cover hire items. This will be returned less any costs for damages and missing equipment. Any charges incurred by Red Carpet Party Hire, in recovering equipment and/or monies will be charged to the hire client.

## 2. Ownership

The equipment supplied is the property of Red Carpet Party Hire.

## 3. Hire Equipment

All Hire equipment is checked for working order, counted and cleaned prior to delivery or collection. Red Carpet Party Hire strives to be an efficient Equipment hire company however it remains the responsibility of the Hirer to check all ordered equipment is delivered and in good order. If any items are missing or incorrect the Hirer is to notify Red Carpet Party Hire immediately so that we can arrange replacements. Failure to notify us will result in client being charged for damaged or missing ordered equipment.

## 4. Insurance

Hire equipment is not insured, all responsibility for loss or damage lies with the hire client.

## 5. Loss, Damage and Cleaning

Any loss, damage or breakage of equipment (including packaging items) will be charged for. All equipment is to be found in a complete state at the end of the hiring period. Linen that requires expert cleaning (ie dry cleaning) will incur an additional charge. Red carpet that requires steam cleaning will incur a \$30.00 charge. Once a marquee is installed, all responsibility for the marquee lies with the hire client. Any loss, damage or breakage will be charged for.

## 6. Indemnity

The Hirer hereby indemnifies and holds indemnified Red Carpet Party Hire from and against all claims, actions, demands and expenses in any way arising from injury, death, loss of income or damage caused to the Hirer or the associated users in respect of the equipment.

## 7. Set up and removal of equipment

Installers of marquees must be informed of location of all underground services including water, gas, electricity, reticulation pipes and telephone cables prior to installation. Whilst all care will be taken, no responsibility is taken for any damage caused to services or other equipment. Any repairs will be at the client's expense. Utmost care will be taken when erecting a marquee, however no liability will be accepted for any damage to property or fixing that a marquee may be attached too.
